ORDINANCE 756-17

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS, PROVIDING FOR THE ADOPTION OF A MUNICIPAL BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; PROVIDING THAT EXPENDITURES FOR SAID FISCAL YEAR SHALL BE MADE IN ACCORDANCE WITH SAID BUDGET; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE OF ALL ORDINANCES; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; AND, PROVIDING AN EFFECTIVE DATE.**

---

**WHEREAS**, the City of Willow Park, Texas ("City"), is a municipal corporation duly and legally formed in the State of Texas; and

**WHEREAS**, the City is a general law municipality with specific powers delegated to it to protect the health, safety and general welfare of its citizens; and,

**WHEREAS**, an annual municipal Budget for the Fiscal Year beginning October 1, 2017 and ending September 30, 2018 ("Budget") was drafted and prepared by the Budget Officer of the City of Willow Park, Texas, in accordance with §§102.002 and 102.003 TEX. LOCAL GOVERNMENT CODE; and

**WHEREAS**, the Budget Officer for the City of Willow Park filed the proposed Budget in the Office of the City Secretary on August 15, and the proposed Budget was made available for public inspection by any person pursuant to §102.005 TEX. LOCAL GOVERNMENT CODE; and

**WHEREAS**, the annual Budget referenced herein is the combination of component budgets for municipal waterworks, wastewater operations and the municipal general fund; and

**WHEREAS**, a public hearing was held on the Budget pursuant to §102.0065, TEX. LOCAL GOV'T CODE, with notice given as required by law prior to the consideration and adoption of the Budget herein; and

**WHEREAS**, after full and final consideration, it is the consensus of the Willow Park City Council that the 2017-2018 Fiscal Year Budget, as hereinafter set forth, should be approved and adopted.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS:**

## SECTION I. AUTHORIZATION

The Mayor, appropriate City Official or Mayor's designee, is hereby authorized and directed to implement the applicable provisions of this Ordinance.

## SECTION 2. APPROVAL AND ADOPTION

The annual Budget for the Fiscal Year 2017- 2018 (attached hereto as Exhibit 'A' and made a part hereof) is hereby approved and adopted.

### SECTION 3. EXPENDITURES

Expenditures during the Fiscal Year shall be made in accordance with this Budget, unless otherwise authorized by the City Council, and said Budget document shall be on file for public inspection in the Office of the City Secretary.

### SECTION 4. CUMULATIVE CLAUSE

This Ordinance shall be cumulative of all provisions of ordinances of the City of Willow Park, Texas, except where the provisions of this ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

### SECTION 5. RECITALS

The City Council hereby finds and declares all precatory language herein to be true and correct and approves and adopts the same herein as part of this Ordinance.

### SECTION 6. SEVERABILITY

If for any reason any section, paragraph, subdivision, clause, phrase or provision of this Ordinance shall be held invalid, it shall not affect any valid provisions of this or any other Ordinance of the City of Willow Park to which these rules and regulations relate.

### SECTION 7. FILING

Subsequent to the adoption of the Budget, a copy of the approved Budget shall be filed with the Municipal Clerk and posted on the Municipal website pursuant to § 102.008, TEX. LOCAL GOV'T CODE.

### SECTION 8. EFFECTIVE DATE

This Ordinance shall be effective on or after its adoption by action of the City Council.

ORDINANCE 757-17

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS, PROVIDING FOR THE ADOPTION OF THE 2017 AD VALOREM TAX (DEBT) RATE AND LEVY OF \$0.2283 PER HUNDRED DOLLARS OF ASSESSED VALUATION ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY; PROVIDING FOR THE 2017 AD VALOREM TAX (MAINTENANCE AND OPERATION) RATE AND LEVY OF \$0.3084 PER HUNDRED DOLLARS OF ASSESSED VALUATION ON ALL TAXABLE PROPERTY WITHIN THE CORPORATE LIMITS OF THE CITY; PROVIDING FOR PENALTY AND INTEREST ON DELINQUENT TAXES AND A LIEN TO ENFORCE COLLECTION; AND, PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Willow Park, Texas ("City"), is a municipal corporation duly and legally formed in the State of Texas; and

**WHEREAS**, the City is a general law municipality with specific powers delegated to it to protect the health, safety and general welfare of its citizens; and

**WHEREAS**, the City Council of the City of Willow Park has received the Tax Year 2017 certified property tax roll submitted by the Parker Central Appraisal District and reviewed the same; and

**WHEREAS**, the effective rate and rollback rate have been duly calculated in accordance with the rules and regulations of the Texas State Property Tax Board and published pursuant to §26.04(e), TEX. TAX CODE; and

**WHEREAS**, a budget appropriating revenues generated by the collection of an ad valorem tax levy and other revenue sources for the use and support of the municipal government of the City of Willow Park was duly and legally adopted by the Willow Park City Council subsequent to a public hearing, as required by § 102.009 of the TEX. LOCAL GOVERNMENT CODE, prior to the consideration of the Ordinance herein; and

**WHEREAS**, the City Council meeting to consider and act upon the Ordinance herein, does in all respects comport with the provisions of §26.06(e), TEX. TAX CODE.

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WILLOW PARK, TEXAS:**

## **SECTION 1. AUTHORIZATION**

The Mayor, appropriate City Official or Mayor's designee, is hereby authorized and directed to implement the applicable provisions of this Ordinance.



## SECTION 2. ACCEPTANCE OF CERTIFIED TAX ROLLS

The certified tax roll prepared and submitted by the Chief Appraiser of the Parker County Central Appraisal District, reflecting the 2017 total certified taxable value for all taxable property within the corporate limits of the City of \$ 491,466,275 is hereby accepted by the Willow Park City Council.

## SECTION 3. TAX RATE STATEMENT

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE; AND THE TAX RATE WILL EFFECTIVELY BE RAISED BY 0.0700 PERCENT AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY \$69.99.

## SECTION 4. APPROVAL OF 2017 TAX RATE AND LEVY

That there be and is hereby levied for the Fiscal Year 2017-2018, on all taxable property, real, personal and mixed, situated within the municipal limits of the City of Willow Park, Texas, and not exempt by the Constitution of the State and valid state laws, a tax of \$0.5367 on each One Hundred Dollars (\$100.00) assessed value of said taxable property, and shall be apportioned and distributed as follows:

(a) For the purpose of defraying the current expenses of the municipal government of the City (maintenance and operation), on each One Hundred Dollars (\$100.00) assessed value of taxable property, there is levied a tax rate of \$0.3084

(b) For the purpose of creating a sinking fund to pay the interest and principal (debt) on all lawful outstanding indebtedness of the City, not otherwise provided for, on each One Hundred Dollars (\$100.00) assessed value of taxable property there is hereby levied a tax rate of \$0.2283 which shall be applied to the payment of such interest and maturities of outstanding indebtedness.

## SECTION 5. PENALTY AND INTEREST

All taxes shall become a lien upon the property against which they are assessed and the Parker County Tax Authority is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and ordinances of the City of Willow Park and shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest; and, the penalty and interest collected from such delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law. All delinquent ad valorem taxes related to penalties and interest for the tax years prior to 2016, which are collected during the fiscal year 2017-2018, shall be allocated to the general fund for maintenance and operation of the City of Willow Park, Texas.

## SECTION 6. RECITALS

The City Council hereby finds and declares all precatory language herein to be true and correct and approves and adopts the same herein as part of this Ordinance.

## SECTION 7. SEVERABILITY

If for any reason any section, paragraph, subdivision, clause, phrase or provision of this Ordinance shall be held invalid, it shall not affect any valid provisions of this or any other Ordinance of the City of Willow Park to which these rules and regulations relate.

## SECTION 8. REPEAL OF CONFLICTING ORDINANCES

All ordinances or resolutions in conflict herewith are and the same are hereby repealed to the extent of such conflict.

## SECTION 9. PUBLICATION AND NOTICE

The City Secretary of the City of Willow Park, Texas is hereby ordered and directed to cause this Ordinance to be published pursuant to §52.011 TEX. LOCAL GOVERNMENT CODE and to forward a copy to the Parker County Tax Assessor Collector.

## SECTION 10. EFFECTIVE DATE

This Ordinance shall be effective on or after its publication of its caption in a newspaper of general circulation stating its purpose and penalty.
