7. Discussion/Action: Schedule Public Hearings to amend 2014 Comprehensive Land Use Plan.

5. Discussion/Action: Authorize Mayor and Staff to proceed with project design, Request For Proposal release, bidding and financing arrangements for water system interconnect projects with final bids and contracts to be brought to City Council for approval.

***Councilmember Martin made a motion to authorize the Mayor and City Staff to ensure that the project design for interconnections with the City of Weatherford for the access of surface water are complete to generate request for proposal and separately to ensure that proposals for financing arrangements are available to support public hearings on April 14, 2015.

6. Discussion/Action: Consider and Act on Resolution 03-15, Authorizing Mayor and City Staff to join Texas Coalition of Affordable Power (TCAP) Electric Utility Provider

***Councilmember Martin made a motion to adopt Resolution 03-15, a resolution authorizing the acceptance of the certificate of formation and bylaws of Texas Coalition of Affordable Power (TCAP), a political subdivision and corporation; accepting membership in said corporation, appointing a representative to serve on behalf of the City; authorizing payment of the membership fee; and providing for an effective date as of the passage of this resolution.
