Invocation & Pledge of Allegiance

Mayor Pro Tem Lea Young asked for a moment of silence followed by the pledge of

allegiance.

The Rules of Procedure states that comments are to be limited to three (3) minutes. The Texas Open Meetings Act provides the following:

A. If, at a meeting of a governmental body, a member of the public or of the governmental body inquiries about a subject for which notice has not been given as required by this subchapter, the notice provisions of this subchapter do not apply to:

(1) A statement of specific factual information given in response to the inquiry; or(2) A recitation of existing policy in response to the inquiry.

B. Any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting.

Without limiting the foregoing, City Council may convene into closed, Executive Session on the following:

A. 551.071 (consultation with attorney): Chapter 380 and Fort Card Room

Following Executive Session, the City Council will reconvene into Regular Session and may take any action deemed necessary as a result of the Executive Session.
