and a 3.38 acre lot generally located at the intersection of Interstate Highway 20 and Crown Pointe Boulevard, northeast corner (PP 015-002).

\*\*\*Councilmember Martin made a motion to adopt the recommendation of the Willow Park Planning and Zoning Commission, to approve the preliminary plat as submitted for the approximately 54.50 acres further described as Lot 2, Block A The Village at Crown Park and Lot 1, Block B Crown Pointe Addition situated in the Wesley Franklin Survey, Abstract No. 468 into a 29.81 acre lot, 10.04 acre lot, 9.35 acre lot, and a 3.38 acre lot generally located at the intersection of Interstate Highway 20 and Crown Pointe Boulevard.
