Froman Survey, Abstract 471, Parker County, Texas, also being a portion of that certain tract described in DOC #201612056, Official Public Records, Parker County, Texas, generally located north of Interstate 20, west of Kings Gate Road and east of the Crown Pointe Subdivision, an addition of the City.
