## **HYDRANT METER USE AGREEMENT**

THIS AGREEMENT is made between \_\_\_\_\_ (hereinafter called the "CONTRACTOR") and Willow Park Water Department (hereinafter called "WP").

In consideration of the mutual covenants contained in this Agreement and other valuable consideration the receipt of which is acknowledged, the parties do hereby agree as follows:

1. On the terms and conditions set out in this Agreement or as otherwise provided here, WP agrees to let the CONTRACTOR use the hydrant meter as shown on page 1.
2. The CONTRACTOR shall use the Equipment only in the manner for which it was designed and intended. The CONTRACTOR shall not permit any Equipment to be used in violation of any federal, state, or municipal laws, ordinances, rules, or regulations, or contrary to the provisions of this Agreement. The CONTRACTOR shall indemnify and hold WP harmless from any and all fines, forfeitures, damages or penalties resulting from violations by the CONTRACTOR.
3. The term of this Agreement shall commence on the date shown on page 1, and ends when the meter is returned to WP for final reading and inspection.
4. The CONTRACTOR agrees to pay WP by the billing due date each month, a \$625.72\* fee for the possession and use of the hydrant meter and backflow assembly in addition to actual water usage charges during the continuance of this agreement.

\*These rates are subject to change. WP reserves the right to change these rates.

5. No Encumbrances: (a) Nothing shall affect WP's absolute ownership of and title to the hydrant meter. The ownership and title are reserved and retained by WP.

6. Return of Equipment: The CONTRACTOR shall at the end of this Agreement or at the earlier expiration, or other termination of this Agreement with respect to the hydrant meter, terminate this agreement by submitting a cancellation of service form to WP.

7. The CONTRACTOR has this day deposited with WP the sum of Two Thousand Three Hundred Dollars (\$2,300.00), the receipt whereof is hereby acknowledged by WP, as security and for the payment of any and all sums of money for which it may be, or become, liable hereunder. Said sum of \$2,300 Dollars shall be returned to the CONTRACTOR, its successors or assigns, at the expiration of this Agreement, provided all the terms, conditions, covenants and agreements herein mentioned have been performed by the said CONTRACTOR, its successors and assigns.
